Dear Ms. Slack, Ms. Salmon, Mr. Gentile, and Mr. Steigleder:

As you undergo the important work of crafting the FY 2027 Labor, Health and Human Services (HHS), and Education (LHHS) appropriations bill, the undersigned organizations thank you for your work toward passage of a strong bipartisan FY 2026 funding bill. The bill and its accompanying reports and joint explanatory statement not only provided robust funding for public health programs but also included important provisions that aim to ensure a well-functioning HHS and greater certainty for partners who, among other activities, conduct life-saving research, track and respond to disease outbreaks, provide front-line services to prevent chronic and infectious diseases, care for our nation's most vulnerable, and train the next generation of medical providers. The health care and public health communities look forward to working with the Committee to build upon the strong, bipartisan FY 2026 process to pass FY 2027 appropriations legislation that further invests in public health, ensures the best stewardship of taxpayer dollars, and guarantees appropriated money is spent as Congress intends.

As you know, last year, the health care and public health communities expressed concerns about atypical flows of funding, especially as it related to timely and predictable processes for grantmaking. In some cases, this led to complete loss of funding and other cases presented uncertainty and confusion for grantees. State and local public health departments, academic medical centers, and other partners rely on federal resources, and these disruptions made it difficult for them to predictably budget, plan, invest in staff and infrastructure. This ultimately led to delays in activities such as clinical trials and decreased services to keep Americans healthy and safe. We are grateful that Congress addressed many of these concerns through important provisions in the FY 2026 LHHS bill.

Notably, the Consolidated Appropriations Act of 2026 requires HHS to support staffing levels necessary to fulfill its statutory requirements. This is key to ensuring the agencies can best meet their missions, including the vital work conducted directly by highly specialized federal employees and the timely and robust review of grant applications. Additionally, the bill requires advanced Congressional notification of grant terminations, ensures timelier publishing of funding opportunity announcements to allow for more robust review of applications, and prevents delays of disbursements of funds to grantees.

This language has already proven helpful in the current funding year. Combined with robust investments across HHS and its agencies, it will continue to improve the workings of HHS, safeguard taxpayer dollars, create

certainty for grantees, and ultimately improve HHS' and our public health, research, patient advocacy, and provider communities' ability to improve the lives and health of the American public.

We again thank you for your work on the FY 2026 funding bill and look forward to working with you throughout the FY 2027 process.
