## REQUIRED DOCUMENTATION CHECKLIST

**Nominator Eligibility:** Voting members of the Endocrine Society including Emeritus members and In-Training Associates with doctoral degrees.

**Instructions:** Nomination package must be merged into one PDF document in the order outlined as follows:

1. One Nomination letter (2 pages max)
2. One Letter of Support (2 pages max)
3. One 300-Word Citation\*
4. Any other Award-specific Requirements
5. Nominee's Curriculum Vitae

Nominations received through the January deadline will be recognized and awarded at ENDO of the following year. Nominations received after that date will be held and considered for the next award cycle.
