To enhance our signature ENDO 2026 meeting, we invite MECs to provide innovative satellite symposia to meeting attendees. All satellite symposia will be live, inperson presentations at an official venue for ENDO 2026 in Chicago, IL. Endocrine Society will continue operating under a symposia time **slot fee model** for ENDO 2026.





#### **About ENDO**

**ENDO** is the signature annual meeting of the Endocrine Society and a highly sought-after international venue for

highlighting the latest in endocrinology research and clinical care. In 2025, we welcomed top names in the fields of clinical endocrinology and hormone science research to deliver more than 185 educational sessions from leading experts from around the world including 75+ symposia sessions. ENDO 2025 also showcased 105 exhibiting companies, more than 2,700 new scientific abstracts, and 2510 scientific posters. Over 7,200 registered attendees (approximately 72% US and 28% from 89 other countries) attended in-person.

Our ENDO 2026 meeting is planned as a **fully in-person** meeting in Chicago IL from June 13-16, to facilitate the most engaging and collaborative meeting possible. Topical areas include, but are not limited to, Adrenal, Bone, Cardiovascular, Diabetes, Parathyroid, Neuroendocrine and Pituitary, Pediatric, Obesity, Reproductive, and Thyroid Endocrinology.

# Satellite Symposia at ENDO 2026

In order to reduce satellite symposia costs to provide ample meaningful educational programming for ENDO 2026 attendees, Endocrine Society is utilizing a <u>symposium slot-fee model</u>. The MEC is responsible for grant development and submission, all event planning and execution, faculty honoraria, outcomes measurements, and financial reconciliation with funders. Upon approval confirmation of funding for proposed satellite symposia, MECs must submit the attached concept paper template to <u>anaser@endocrine.org</u> for approval to be held in conjunction with ENDO 2026. After a fully executed LOA has been provided to Endocrine Society and the concept paper has been approved, a time slot can be secured. The slot fee for ENDO 2026 satellite symposia is \$75,000.

Endocrine Society will provide the following for satellite symposia:

• An assigned two-hour meeting slot which includes a 30-minute breakfast or dinner break and one and one-half (1.5) hours of content

Available times slots are as follows:

- Sunday, June 14; 6:00 am 8:00 am; 7:00 pm 9:00 pm
- o Monday, June 15; 6:00 am − 8:00 am; 7:00 pm − 9:00 pm
- o Tuesday, June 16; 6:00 am − 8:00 am
- \* (2) sessions per each time slot
- A meeting room in a banquet set for approximately 250 attendees. **The room set cannot be changed**.
- A registration table with 2 chairs and a wastebasket outside of the meeting room

# Signage Guidelines for Satellite Symposia

The guidelines for displaying signs onsite during ENDO 2026 are:

- 1. Placement of one standing sign (meter board) outside of the satellite symposium room. (Note: Sign design and printing is at the expense of the satellite host.)
- 2. Placement of one registration sign (no larger than 28"x44") in proximity to the registration desk outside the meeting room. (Note: Sign design and printing is at the expense of the satellite host.)
- 3. Posting additional signage elsewhere in the hotel is prohibited and will be removed.
- 4. Satellite symposia managers must remove signage immediately following their activity.
- 5. Human-directionals may be used in the pre-function areas prior to the start of your satellite symposium activity; however, solicitation of your event is not permitted at any other time of the meeting. (Note: Sign design and printing is at the expense of the symposia host.)

You will have access to your room **3 hours** before your scheduled symposium. Your symposium, including the food and beverage function, may not exceed the scheduled time frame.

- A head table with (2) chairs and (2) table microphones
- Stage
- Podium and podium microphone
- (2) audience microphones

Livestream for an external audience is optional and any related costs to hosting a livestream event is the responsibility of the MEC, including all internet fees. Any AV or additional décor ordered in addition to the standard AV set is the sole responsibility of the planning and/or medical education company coordinating the symposium and **is not** included in the satellite symposia fee that is paid to Endocrine Society. You are required to order any additional equipment through the Endocrine Society's exclusive supplier, Freeman.
